Admission Information in accordance with Chulalongkorn University Announcement on Admission to the Bachelor of Business Administration International Program Faculty of Commerce and Accountancy for the Academic Year 2021 (Early Admission)

Admission Criteria:

The Chulalongkorn University Board of Governance has authorized the Bachelor of Business Administration International Program, Faculty of Commerce and Accountancy Program, to select applicants for the following two majors in the Academic Year 2021 (Early Admission):

- International Business Management major
 - International Business Management field
 - Financial Analysis and Investment field
 - Brand and Marketing Management field
- Accounting major

Admission Criteria:

1. Applicant Requirements

- 1.1 Applicants must not be younger than 17 years old and must have complete/be completing M6 <u>or</u> its equivalent levels in Thailand.
- 1.2 Applicants must achieve the minimum score on <u>one</u> of the following English proficiency tests:

TOEFL (Internet-based) not lower than 79
 IELTS (Academic) not lower than 6.5
 OR

- CU-TEP & Speaking (Chulalongkorn University Test of English Proficiency)

not lower than 101 (for the same test date)

- 1.3 Applicants will be evaluated on their ability to communicate in English and their Mathematic proficiency from the following test:
 - SAT (Math and Evidence-Based Reading and Writing) not lower than 1270 In submitting the scores of SAT (Math and Evidence-Based Reading and Writing), the test scores must be taken on the same date.

All scores according to 1.2 and 1.3 must be for examinations taken within two years of the application date. The applicants must submit the electronic exam results according to the instructions specified under Items 4.2.4 and 4.2.5

1.4 Applicants must maintain a history of proper behavior and strictly abide by the existing and upcoming University's regulations, principles and announcements.

If there is evidence shown later that the application does not meet the requirements or contains fraudulent information, involves fake documents, the application will be rejected, even though an offer of admission has already been made. Moreover, the applicant may be prosecuted according to law.

2. Admissions

The Bachelor of Business Administration International Program (International Business Management major and Accounting major) is authorized to admit up to **one hundred and ninety qualified applicants**.

In case the number of qualified applicants is less than one hundred and ninety, the remaining slots will be added to the next admission of academic year 2021.

 - 4.2.4.1 If an applicant selects the TOEFL, the result must be sent by ETS directly to the Bachelor of Business Administration International Program. Please use the code for the <u>Chulalongkorn BBA 4559</u>
 - 4.2.4.2 If an applicant selects the IELTS exam, the result must be sent by British Council or its testing center directly to the Bachelor of Business Administration International Program. Please use the code for the <u>Chulalongkorn BBA 138499</u>
 - 4.2.4.3 If an applicant selects the CU-TEP & Speaking exam, the original score report issued by Chulalongkorn University Academic Testing Center must be submitted. The score report can be obtained at Chulalongkorn University Academic Testing Center, 3rd floor Chamchuri 8
- 4.2.5 Electronic exam results according to requirement 1.3:

The electronic SAT result must be sent by the College Board directly to the Bachelor of Business Administration International Program. Please use the code for the Chulalongkorn BBA 4559.

Note: The electronic exam results according to requirement 4.2.4.1–4.2.4.2 and 4.2.5 the applicants must inform the ETS, The College Board or IELTS to report electronic results officially to the BBA Program before the applicants create the online application at our website: http://admission-bba.acc.chula.ac.th/

The applicants must submit all documents in the applicant packet. An incomplete application packet will not be considered.

5. Sele

5.1 Evaluation Criteria for Interview Shortlist

Each application will be evaluated on the admission criteria and test scores according to requirement 1.3 by Faculty of Commerce and Accountancy.

5.2 Interview Shortlist Announcement

Applicants short-listed for the interview will be announced on <u>January 26, 2021</u> at the BBA International Program Office, 4th Floor, Building 8, Faculty of Commerce and Accountancy, Chulalongkorn University and on website: http://bba.acc.chula.ac.th

The announced number of applicants shortlisted for interview may be greater than the intended number of students to be admitted to the program due to the expectation of not showing up for the interview by some applicants and not confirming the enrollment.

5.3 Interview

Interviews for the short-listed applicants will be held during the <u>January 29–31, 2021</u> period at the Faculty of Commerce and Accountancy. Applicants not coming for the interview on the specified date will forfeit their opportunity for admission.

5.4 Evaluation Criteria for Applicants to be selected

Applicants will be evaluated on their admission criteria and test scores according to requirement 1.3. The applicants must pass the interview conducted in English arranged by the Bachelor of Business Administration International Program, Faculty of Commerce and Accountancy.

5.5 Preliminary Selection Announcement

Preliminary selected applicants will be announced on <u>February 8, 2021</u> at the BBA International Program Office, 4th Floor, Building 8, Faculty of Commerce and Accountancy, Chulalongkorn University and on website: http://bba.acc.chula.ac.th. The Faculty of Commerce and Accountancy will announce the list of selected applicants who passed the interview in accordance with the intended number of admitted applicants to the propram. The number of selected applicants may be more than the intended number of admitted applicants if those selected applicants in the lowest ranking eligible for selection have the same score according to requirement 1.3

5.6 Enrollment Confirmation

The preliminary selected applicants must come to confirm the enrollment on <u>February 10</u>, <u>2021</u> (9:00 a.m.–11:00 a.m.) at the BBA International Program Office, 4th Floor, Building 8, Faculty of Commerce and Accountancy, Chulalongkorn University. Applicants who do not show up on the specified date and time will forfeit their opportunity for admission, and the additional selected applicants who passed the interview will be announced in order to reach the intended number of admitted applicants on <u>February 11</u>, <u>2021</u> (9:00 a.m.). The additional selected applicants must come to confirm the enrollment on <u>February 12</u>, <u>2021</u> (9:00 a.m.–11:00 a.m.) (if any)

5.7 Announcement of Selected Applicants

Selected applicants will be announced on <u>February 22, 2021</u> at the BBA International Program Office, 4th Floor, Building 8, Faculty of Commerce and Accountancy, Chulalongkorn University and on website: http://bba.acc.chula.ac.th. The selected applicants must perform an online confirmation

report (round 1) through the TCAS64 system (http://student.mytcas.com) during <u>February 22–23, 2021</u> according to the Council of University Presidents of Thailand. If selected applicants do not perform the online confirmation report within the specified period, it means that the applicants reject the admission to the program for the academic year 2021 (Early Admission). In case there are fewer than 190 selected applicants who performed the online confirmation report in the TCAS system, the remaining seats will be added to the next admission round for the academic year 2021. And this is the end of the application process. The university will not announce any additional selected applicant.

5.8 Waiving the Right to enroll through the TCAS System

The selected applicants to the program for the Early admissions round who already performed the online confirmation report in the TCAS64 system during February 22–23, 2021, but wish to waive the right to enroll in the program. The applicants could waive their right through the TCAS64 system (http://student.mytcas.com) during **February 24–25, 2021.**

5.9 Announcement of the list of confirmed applicants in the 1st round of TCAS64

6. Enrollment Conditions

To be eligible to enroll for the first registration as Chulalongkorn students, enrollees must have completed M6 or its equivalent level.

For the ones who graduated from international schools in Thailand or from overseas, which are not certified by the Ministry of Education. It is required to get the certification from Chulalongkorn University in certifying the equivalency with the Thai educational system.
