



Chulalongkorn University Announcement
For Chinese Students from The People's Republic of China
Admission to the Bachelor of Business Administration International Program
Faculty of Commerce and Accountancy
for the Academic Year 2019

Admission Criteria:

The Chulalongkorn University Board of Governance has authorized the Bachelor of Business Administration International Program, Faculty of Commerce and Accountancy Program, to select applicants for the following two majors in the Academic Year 2019:

- International Business Management major
 - International Business Management
 - Financial Analysis and Investment
 - Brand and Marketing Management
- Accounting major

Admission Criteria:

1. Applicant Requirements

- 1.1 Applicants must complete/be completing high school from The People's Republic of China.
- 1.2 Applicants must be at least 17 years old and be a citizen of The People's Republic of China.
- 1.3 Applicants must submit the documents according to the requirements below:
 - 1.3.1 China Secondary Education Student Academic Transcript with the accumulated (overall) grade point average (GPAX) of not lower than 3.00
 - 1.3.2 China National College Entrance Examination (Gaokao) Score in English subject of not lower than 125
 - 1.3.3 China National College Entrance Examination (Gaokao) Score in total not lower than 580

All scores according to 1.3.2 and 1.3.3 must be from the examinations taken at the same time and within two years of the application date.

- 1.4 Applicants must maintain a history of proper behavior and strictly abide by the existing and upcoming University's regulations, principles and announcements.

2. Admissions

The Bachelor of Business Administration International Program (International Business Management major and Accounting major) is authorized to admit up to **six qualified applicants**.



3. Application Process

Qualified applicants can **apply online** through our website <http://bba.acc.chula.ac.th> from **March 1, 2019 until March 25, 2019**. as follows:

- 3.2 Print the application card
- 3.3 Make the application fee payment of Baht 1,000 by one of the following methods:

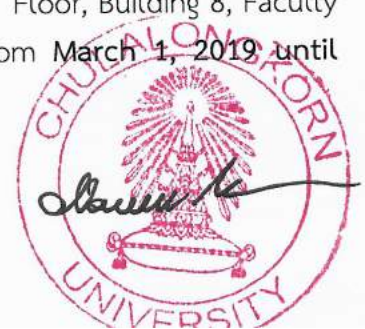

3.3.2 Payment at the Siam Commercial Bank PCL

3.4 Submit the application card with the application packet according to Item No. 4 – Application Packet by either one of the following means:

- 3.4.1 Applicants may submit the application packets in person at 4th Floor, Building 8, Faculty of Commerce and Accountancy, Chulalongkorn University from **March 1, 2019 until March 25, 2019 (8.00 am - 4.00 pm)**.

Applicants by mail will be accepted from **March 1, 2019 until March 25, 2019** and no applications postmarked later than **March 25, 2019** will be accepted.

No refund will be made after the application has been submitted.

4. Application Packet

Applicants must complete the application form thoroughly and all information provided must be correct and factual. The incomplete application packet will not be considered. All application forms must be accompanied by the following:

- Applicant's card with two one-inch (1") photographs
- A copy of China Secondary Education Qualification Certificate
- A copy of China Secondary Education Student Academic Transcript
- A copy of China National College Entrance Examination (Gaokao) Score Report
- A copy of the applicant's passport
- A proof of application fee payment

As an official proof of the applicant's graduation documents, the following documents need to be issued by

China Credentials Verification (CHESICCC):

- Verification Report of China Secondary Education Qualification Certificate
- Verification Report of China Secondary Education Student Academic Transcript
- Verification Report of China National College Entrance Examination (Gaokao)

5. Evaluation Criteria

Successful applicants will be evaluated on their admission criteria and test scores according to requirement 1.3. The applicants must pass the personal interview conducted in English arranged by the Bachelor of Business Administration International Program, Faculty of Commerce and Accountancy. Applicants will be informed of the date of the interview by email.

6. Interview Shortlist Announcement

Applicants short-listed for the interview will be announced on **March 28, 2019** at the BBA International Program Office, 4th Floor, Building 8, Faculty of Commerce and Accountancy, Chulalongkorn University and on website: <http://bba.acc.chula.ac.th>

The number of applicants shortlisted for the interview may be greater than the number of students accepted to the program due to withdrawal of the applicants and less than the number of the students accepted to the program due to the lack of qualifications.



7. Interview

Interviews for the short-listed applicants will be held on the **March 30, 2019**. Applicants fail to appear for the interview on the specified date will forfeit their opportunity for admission.

8. Final Selection Announcement

Selected applicants for the BBA International Program will be announced on **April 27, 2019** at the BBA International Program Office, 4th Floor, Building 8, Faculty of Commerce and Accountancy, Chulalongkorn University, and on the website: <http://bba.acc.chula.ac.th>

Selected applicants must confirm their decision for Enrollment with the BBA International Program by paying the confirmed fee on **April 30, 2019 (8.00 am–4.00 pm)**. Failure to do so will result in official rejection from the Program.

The Committee's resolution is absolute.

9. Enrollment Confirmations

To be eligible to enroll for the first registration as Chulalongkorn students, enrollees must have completed China Secondary Education Qualification.

10. Tuition Fees and Special Tuition Fees

Tuition fees and special tuition fees are charged in accordance with the Announcement of Chulalongkorn University on the Collection of Tuition Fees and Other Fees for the Bachelor of Business Administration International Program (International Business Management major and Accounting major), Faculty of Commerce and Accountancy.
